Interplast was incorporated on 19 May 1983 and we received tax-deductibility status the following year. I recall receiving a letter from the then Treasurer, the Honourable Paul Keating, granting that status. Interplast was the culmination of many discussions and meetings between representatives of the Royal Australasian College of Surgeons and Rotary District 9800. It was the dedication of a number of people and the organisations they represented that led to the incorporation of Interplast and its ongoing success. Sir Benjamin Rank, one of Australia's foremost plastic surgeons, was President of Interplast for eight years. His family continues to support the organisation today. 30 years of Interplast would not be complete without acknowledging

the man I am pictured with here, Professor Donald Marshall AM who, since 1983, has dedicated himself to the organisation, serving as President for 16 years following Sir Benjamin. He currently acts as our Patron. Thanks to Sir Benjamin and Professor Marshall's commitment and vision, Interplast has grown and prospered.

As is fitting with a 30th celebration, this has been a big year.

We have had a strong focus and commitment working towards our AusAID re-accreditation. While important in its own right, the journey is also a valuable exercise in strengthening our internal corporate governance protocols.

In the past year we also implemented our first major evaluation study in Fiji. Pulling together 30 years of history and activities, it included an eight-day in-country evaluation where over 60 participants, including past patients, families, local trainees and other key stakeholders were interviewed.

We also approved of our new five-year strategic plan, outlining our vision

to ensure people in developing countries across the Asia Pacific region have timely access to high quality surgical, medical and allied health services. We have previewed elements of this plan at the beginning of this report.

30 years is a long time! We have reached our 30th milestone because of our remarkable supporters – our thanks are extended to our donors. in-country partners, corporate supporters, our Board of Directors and Committee members, staff members and volunteers. It's been wonderful to celebrate with our volunteers and to hear their personal experiences, has been rewarding. We could not have done it without our volunteers - they have transformed lives and have actively contributed to improving healthcare systems in our neighbouring countries by empowering the locals through training. That is a significant contribution and something of which to be enormously proud.

We look forward to meeting the challenges and opportunities for Interplast in the coming years and increasing the profile of Interplast's work so we continue to meet the needs of those less privileged in our neighbouring developing countries.

Our 30th anniversary has provided the Board and staff with the chance to acknowledge personally and formally thank all our volunteers, corporate and private supporters and Rotary clubs for their contribution to making Interplast what it is today. It was also the perfect opportunity to implement a formal recognition process to acknowledge the amazing and often unsung work of our volunteers.

There have been some clear priorities for Interplast over the financial year:

Our anniversary has given us a great excuse to spread the word about Interplast and the great work you've allowed us to do. Our new website and our Facebook page are important vehicles in telling our story and in sharing experiences. We've received great assistance from many volunteers who have been prepared to share their experiences

across a range of media about what it means to volunteer for Interplast and their impact, at both an individual and systemic level across the Asia Pacific.

The year has also been a time for equipping the organisation with the foundations to move into its next phase. We've been reviewing and developing policies and procedures to strengthen the organisation while continuing to develop our service philosophy with a clear focus on building capacity and fully embedding monitoring and evaluation into all our activities. The formal reviews of our programs in Cambodia, Fiji and Vietnam are all excellent demonstrations of this approach.

And the year has been one for building partnerships. The key to doing better is to do it together. We've established more formal agreements with the Australian College of Anaesthetists (ANZCA), Children First Foundation and a number of local partners. We've also formalised our arrangements with our corporate supporters, including the establishment of a five-year agreement with Avant.

As a proud signatory to the Australian Council for International Development (ACFID) Code of Conduct, Interplast has continued to build its focus on developing the skills and knowledge of local medical professionals in all our activities. This is reflected by this year's activities breakdown - for the first time, Interplast has undertaken more activities with a primary purpose of education and training than surgical services.

Our program coordinators spend a lot of time communicating with our local partners across all the countries in which we work to ensure timings and activities align. While there have been many achievements this year, unfortunately, we were unable to proceed with three of our larger surgical activities due to internal country issues. We are hoping all these activities will resume in 2013/14.

None of this could be achieved without a huge team effort. I would particularly like to thank all the staff for their work above and beyond. And of course, our volunteers and supporters at all levels. We couldn't do it without you!

JULY 2012

We spoke at the Rotary International Directors' Briefing weekend in Parramatta this month. An opportunity for all District Governors Elect to be introduced to various Rotary-supported organisations and projects, it was a great chance to tell Interplast's story and spread the word.

AUGUST 2012

We established a new program activity in Laos to include Phonsavan, in the country's northeast. Over the course of two weeks, medical staff from Vientiane and Phonsavan received on-the-job training from our Interplast volunteer team and 50 patients received life-changing surgery.

SEPTEMBER 2012

We launched our new website – www.interplast.org.au! After months of hard work, our online identity now reflects who we are, what we stand for and how you have repaired bodies and rebuilt lives across the Asia Pacific region.

OCTOBER 2012

To promote the iconic fundraising event, the Eureka Climb, and the work of charity partners, Interplast and Whitelion, Scott McGraw ran up the stairs of Melbourne's tallest tower 31 times in a row! That's the equivalent height of Mount Everest! 51,000 steps and 11 hours later, he did it.



We delivered another successful surgical activity to Mt Hagen in Papua New Guinea. The Interplast volunteer team of two surgeons, two anaesthetists and two nurses were accompanied by two corporate supporters and one staff member. With 85 patients waiting to be consulted, our team was able to perform 47 life-changing procedures, while also training the local medical staff.

DECEMBER 2012

Our commitment to capacity building was highlighted this month, when the Board endorsed our new Development Philosophy. A key framework, it articulates our commitment to long-term development, people with disabilities and gender equality and guides the behaviours, practices and decision-making of all Interplast personnel and volunteers. The Development Philosophy guides all Interplast programs to ensure they're implemented effectively, with development outcomes reached.







JANUARY 2013

We knew our 30th year would be a big one. So, in anticipation of our birthday in May, we commenced a short PR campaign to promote our milestone, our supporters, our volunteers and our achievements. The campaign officially kicked off in January, with the incredible work of our supporters being celebrated across many media channels.



We started implementing Interplast's first major impact/evaluation study! A huge task, the study pulled together 30 years of history and activities in Fiji and included an eight-day in-country evaluation where over 60 participants, including past patients, families, local trainees and other key stakeholders were interviewed.

MARCH 2013

We hosted our annual Black & White Ball in Sydney this month. As well as raising funds for our program activities, it also served as a fantastic opportunity for Interplast's volunteers and their families, corporate supporters, donors and fundraisers to gather and celebrate their role in repairing bodies and rebuilding lives.

A team of enthusiastic Interplast supporters, dubbed the Vikings, trekked the Kokoda Track in Papua New Guinea and raised \$35,000 towards Interplast's surgical and training activities in the country.

As part of the Marshall International Scholarships, and our focus on capacity building, we funded four surgical registrars from Indonesia, Fiji and Papua New Guinea to attend this year's Australian Society of Plastic Surgery Congress in Melbourne.

MAY 2013

We reached a significant milestone – our 30th anniversary! Celebrating our birthday in style, we commenced the celebrations with three anniversary cocktail parties – one each in Melbourne, Sydney and Perth – to thank all those who've supported us since 1983.

Since 2006, Interplast has assisted Nepal with the development of reconstructive microsurgery services. To date, we've delivered seven comprehensive training modules and in September 2012, our Interplast volunteers were joined by an Interplast hand therapist to assist in strengthening hand rehabilitation for Nepalese patients. Kathmandu Model Hospital continues to undertake independent microsurgery cases with distant support from Interplast volunteers.



BANGLADESH



LA0S

Interplast's focus on building the capacity of the local Bangladeshi medical staff has continued this year, with another microsurgery mentoring activity in May 2013. The trip coincided with the 3rd Bangladesh Plastic Surgery Conference – Plasticon 2013, where Interplast surgeons presented papers and chaired a number of sessions. The trip saw the team provide microsurgery training, run a trial training session and write protocols for microsurgery training modules.

This year, we expanded our programs in Laos to the province of Xieng Khouang! Six Interplast volunteers, as well as in-country medical staff from Mahosot General Hospital in Vientiane, travelled to the northeast of Laos to provide critical and otherwise unavailable surgical services to the local community. Over the course of two weeks, 73 patients were consulted and 50 patients received life-changing surgery. 84 per cent of all surgeries performed were to relieve burn scar contractures.



BANGLADESH

Country Coordinator: Mr Russell Corlett

The activities in Bangladesh for the year were strongly focused on capacity building. Two key individuals from the Centre for Injury Prevention and Research, Bangladesh (CIPRB) were supported to attend and present at international conferences. Dr Saidur Mashreky attended the 16th Congress of the International Society of Burn Injuries (ISBI) in Edinburgh, Scotland where he discussed the collaborative work between Interplast and CIPRB. He also presented on burn disaster issues in low-income countries and burn education and management strategies. In October 2012, Dr Animesh Biswas from CIPRB attended the 11th World Conference on Injury Prevention and Safety Promotion in Wellington, New Zealand, presenting on the 'Emergency Management of Severe Burns (EMSB) Program: A New Dimension in Burn Management in Bangladesh.'

Interplast continued to support CIPRB in the delivery of EMSB courses in December 2012 and June 2013. In February 2013, in partnership with ANZCA (Australian and New Zealand College of Anaesthetists) Interplast piloted the Essential Pain Management (EPM) course in Dhaka. A great success, 49 participants attended with 10 being selected to be key instructors for future delivery of the EPM.

In May 2013, a team of five volunteers undertook a microsurgery mentoring activity in Dhaka.
The team presented papers and participated at the 3rd Bangladesh Plastic Surgery Conference – Plasticon 2013, assisting the local team with microsurgical procedures and writing protocols for training modules in microsurgery.

CAMBODIA

No Country Coordinator

In May 2013, funding from the Planet Wheeler Foundation enabled Interplast to assess the opportunities for building on the current Cambodian program. A team of three volunteers and two staff members visited Siem Reap, Battambang and Phnom Penh to establish the feasibility of implementing new surgical and training activities in the country.

The team visited the Angkor
Hospital for Children (AHC) and Siem
Reap Provincial Hospital in Siem
Reap and Battambang Provincial
Hospital in Battambang. Meetings
were held with non-government
organisations and individuals with
an understanding of the Cambodian
health sector. A meeting with the
Under Secretary of State at the
Ministry of Health, H.E. Professor Dr
Thir Kruy also took place.

The assessment indicated that although there are challenges in working in Cambodia – due to the

high volume of non-government organisations already positioned in the health system - there are significant opportunities for Interplast to contribute to capacity building in the country. As such, planning is underway to implement a capacity building activity in Cambodia in 2014.

FIJI

Country Coordinator: Mr Simon Thomson

This year, four separate surgical visits took place in Fiji – one each in Lautoka and Suva and two in Labasa. All four of these activities had a significant training focus, with the Fiji Ministry of Health now supporting one or more surgical registrars, with an interest in plastic surgery, to join the team for the duration of the visits, as well as providing pre-screening and postoperative support. The total number of patients consulted during these four visits was 236 and a total of 118 surgical procedures were performed.

In addition to these four visits, two Fijian surgical registrars, with an interest in plastic surgery, Dr Esala Vakamacawai and Dr Rachna Ram, were funded under Interplast's Marshall International Scholarships to attend the Australian Society of Plastic Surgery Congress in Melbourne in April 2013. Dr Vakamacawai, along with three of his Fijian surgical colleagues

(Dr Tudravu, Dr McCaig Jnr and Dr Matanaicake Jnr) also attended the Applied Reconstructive Surgical Skills workshop in Hobart in May 2013.

Excitingly, this year saw the development and implementation of Interplast's first major impact/ evaluation study, pulling together 30 years of history and activities in Fiji. This included an eight-day in-country evaluation component, where over 60 participants, including past patients, families, local trainees and other key stakeholders were interviewed. The report identified a series of recommendations which will guide the future of Interplast's programs in Fiji. (Read more about this study on pg 20).

INDONESIA

Country Coordinator: Mr Ian Carlisle

This year, Interplast was only able to partially implement an activity to Balikpapan due to the postponement of all Indonesian activities in the 2012/13 financial year. Surgeon, John de Waal, was able to work with the local team in Balikpapan for one week in May 2013. Given the limited resources and timeframe, he, alongside two local plastic surgeons, Dr Djohan Wirawan and Dr Rahmad Dianto, as well as registrars from

the Indonesian Association of Plastic Surgeons (PERAPI), managed to provide consultations to 98 patients with 24 receiving surgical treatment. Without a full Interplast team, the shortened activity demonstrated the increased capacity of the local medical professionals in Indonesia to administer these services. In addition, two Indonesian anaesthetic registrars, Dr Siti Nurchafida and Dr Herdiani Sulistyo Putri, attended a four-week professional development program in Ballarat in September 2012. 
KIRIBATI


Country Coordinator: Mr Miklos Pohl

In December 2012, the regular Interplast surgical visit to Tarawa in Kiribati was led by Interplast's volunteer Country Coordinator and surgeon, Miklos Pohl, and included surgeon, Sian Fairbank (on her first Interplast activity), anaesthetists, Andrew Jowitt and Claudia Krellman and nurses, Fiona Podbury and Sue Graham. With most of this team having volunteered in Kiribati in previous years, it was a chance for them to re-connect with their local colleagues.

Over the course of the week, the team saw 74 patients, with 56 surgical procedures undertaken. This included a number of cleft lip and palate repairs,







burn scar contracture releases and the treatment of other congenital and acquired conditions.

LAOS

Country Coordinator: Mr Philip Slattery (previously Mr Chris Bennett)

In Vientiane, a total of 210 people (from across the country) received consultations from the Interplast and Mahosot General Hospital teams. This number was the largest for any Interplast Laos activity since the country program began in 1995. Of this number, 60 people received surgical treatment. This increased reach was due in part to working closely with various in-country stakeholders in communicating the purpose and focus of Interplast's work. A highlight was the visit from the then Minister for Foreign Affairs, Senator the Hon Bob Carr, who was able to meet and observe the Interplast team in action.

A second trip to the Lao-Mongolian Friendship Hospital in Phonsavan saw six Interplast volunteers travel to the remote Xieng Khouang province in August 2012. This was the first of three annual activities funded by Phu Bia Mining. 73 patients were consulted. Of the consultations, 50 received life-changing surgical treatment. This activity was also very training focused as it allowed a local surgical team from Mahosot General

Hospital in Vientiane to travel to the rural province to work alongside the Interplast team.

This model of capacity building also saw the transfer of skills and knowledge between the Mahosot General Hospital staff and the Lao-Mongolian Friendship Hospital staff. This was further highlighted through the work of the Mahosot Outreach Team in March 2013, which provided training to the medical staff at the Savannakhet Provincial Hospital in Savannakhet.

MONGOLIA

Country Coordinator: Dr David Pescod

This year, Interplast provided financial support to the Mongolian Society of Anaesthetists (MSA) to plan and implement the annual MSA conference in Ulaanbaatar. As a result, collaboration between MSA and the Australian Society of Anaesthetists (ASA) saw 30 Interplast volunteers deliver specialised training during the conference.

With impressive attendance, over 100 doctors participated and focused on various topics, which included:

 Piloting a two-day Initial Emergency Care (IEC) and instructor course in Ulaanbaatar.
 11 Interplast volunteers led

- these courses, acting as IEC instructors. MSA secured doctors from secondary and tertiary hospitals to participate in the course, which was then implemented in the regional areas of Arkhangai and Khentii Aimag.
- The WHO Patient Safety Pulse
 Oximetry Project, which focuses

 countries, was introduced to
 Mongolia during the conference,
 with Interplast volunteers
 conducting a teaching workshop

- An Essential Pain Management (EPM) course was delivered in Ulaanbaatar, Arkhangai and Khentii Aimag by three Interplast volunteers.

NEPAL

Country Coordinator: Mr Damien Grinsell

In September 2012, an Interplast microsurgery training activity to Kathmandu in Nepal was led by Interplast's volunteer Country Coordinator and surgeon, Damien Grinsell and included surgeon, Scott Ferris, anaesthetist, Stephen Hur and nurses, Stephanie Gardiner and Wendy Gale. The team focused on the effectiveness of the training provided by Interplast teams on previous visits and the level of competence acquired by the local







team. The Interplast team provided consultations to 14 patients with four selected for surgical treatment. In addition, Wendy Gale delivered a three-day plastics and reconstructive nurses' course which was well attended, while Beth McNeish, an Interplast hand therapist, worked with the local hand therapists to assist in the development of the allied health sector.

Throughout the year, local staff at the Kathmandu Model Hospital carried out three independent microsurgery cases, with remote support and guidance from Interplast volunteers in Australia.

PAPUA NEW GUINEA

Country Coordinator: Mr Simon Donahoe

Three surgical visits were undertaken in Papua New Guinea this year – one each to Lae and Mt Hagen and a hand surgery visit to Madang. Over the course of these visits, 214 consultations were provided and 138 surgical procedures performed. In addition, 32 hand therapy treatments were carried out by Interplast's hand therapist who joined the Madang team. PNG's plastics trainee, Dr Morath Maire, joined the Madang and Mt Hagen activities to work alongside

the Interplast teams where he received valuable in-theatre training. During the 2012/13 financial year, three specific mentoring activities, based at the Port Moresby General Hospital (PMGH), took place. One activity focused on burns treatment and surgery, one focused on cleft, head and neck surgery, and one focused on hand surgery. All three visits focused on mentoring Dr Maire and various other local surgical personnel, including the University of Papua New Guinea Masters of Medicine trainees.

During the year, Dr Maire also participated in a number of overseas training attachments including the Applied Reconstructive Surgical Skills workshop in Hobart, the Australian Society of Plastic Surgery Congress in Melbourne (under the Marshall International Scholarships) and two short placements at the Peter MacCallum Cancer Centre in Melbourne and the Royal Hobart Hospital in Tasmania.

PHILIPPINES

Country Coordinator: Dr Michael McGlynn OAM

In November 2012, a team of six volunteers successfully completed Interplast's annual activity to Baguio

City. In total, 61 patients received treatment with over 60 per cent requiring cleft lip and palate repair. Local general surgeon, Dr Rolando Canival, received one-on-one mentoring from Interplast volunteer, Peter Haertsch, in burns and graft management, while the local nurse, Val Smith-Orr, received specialised burns dressing training from the team.

In February 2013, Interplast undertook a planning and evaluation assessment of Masbate province following a request from mining company, Filminera Resources Corporation and the Masbate local Governor Hon Ruizalina Seachon-Lanette. An Interplast team visited Masbate to establish the feasibility of collaborating with Filminera Resources Corporation to deliver an activity in the future. They have since committed to fund three annual program activities, which will commence in February 2014.



SAMOA

Country Coordinator: Dr Benjamin Norris

In the 2012/13 financial year, Interplast implemented one program activity in Samoa - a two week plastic and reconstructive surgical and training visit to Apia in August 2012. During this visit, 86 patients







were consulted with 42 life-changing surgical procedures being performed. Local nursing, anaesthetic and surgical staff received hands-on training in clinic, theatre, recovery and in the wards during the visit. Interplast surgeon, Damian Marucci, gave a well-received lecture on the reconstructive ladder and nurse, Simone Kairouz, provided training materials to the local nursing staff.

In addition to this visit, Dr Dyxon Hansell was a participant in the Applied Reconstructive Surgical Skills workshop in Hobart in May 2013, where he spent two intensive days being taught by six leading Interplast volunteer plastic surgeons.

SOLOMON ISLANDS

This year, Interplast conducted an outreach visit to the island of Gizo, as well as the annual surgical visit to the National Referral Hospital in Honiara. The team comprised surgeons, Darrell Nam and John Carney, anaesthetist, Vernon Moo and nurses, Jan Sloan and Helen Jarczak. The team was also joined by Rotarian observers, Albert Kramer and Valda Bray. This was the first time Interplast has sent a team to Gizo in several years. It served as a great opportunity to assess the hospital's facilities and personnel

capacity to host such as visit and allowed the consultation of a number of patients as well as several surgical procedures. Having worked alongside the Interplast team this year, the local Gizo team will be well equipped to pre-screen and host another visit next year, allowing patients who are located a significant distance from Honiara to access surgery. 79 consultations and 37 procedures were provided during this year's visit.

SRI LANKA

Country Coordinator: Mr Randall Sach

This year saw an expansion of Interplast's country program to Batticaloa, located in the eastern province of Sri Lanka. Interplast volunteers, together with a team from the National Hospital of Sri Lanka, worked at the Teaching Hospital of Batticaloa in September 2012. The team comprised surgeons, James Savundra and Philip Slattery, anaesthetists, Elmo Mariampillai and Chris Johnson and nurses, Linda Ferguson and Gill Bathgate.

In total, 125 patients were consulted, with 55 procedures being performed. The cases were generally burn scar contracture releases and congenital hand injuries. James Savundra also delivered an 'Introduction to Plastic

Surgery' lecture to an auditorium of approximately 150 people including many medical students. This was well received. It is hoped one of these medical students will pursue this field, becoming the first Tamil plastic surgeon from the eastern province region of Sri Lanka.


In October 2012, the annual Interplast surgical visit to Nuku'alofa in Tonga included surgeons, David Morgan and Graham Sellars, anaesthetist, Lian Pfitzner and nurses, Alison Osmen and Suzanne Wills. The team was also joined by Rotarian observers, Judy Berends and Kathryn O'Connor.

Over the course of the week, the team consulted 98 patients, with 48 surgical procedures being performed, including a number of cleft lip and palate repairs, burn scar contracture releases and the treatment of other congenital and acquired conditions. David Morgan delivered a lecture during the Grand Rounds focusing on the management of facial trauma while Graham Sellars focused on the one-on-one training of Dr Kolini in theatre. Suzanne Wills also presented to the surgical nurses on cleft surgery.

VANUATU

Country Coordinator: Mr Ian Holten

In June 2013, the annual Interplast surgical visit to Port Vila in Vanuatu was led by volunteer Country Coordinator and surgeon, Ian Holten, and included surgeons, Mark Duncan-Smith and Rebecca Wyten (on her first Interplast program), anaesthetist, Rob Grace and nurses, Helen Chadwick and Tanya Karal.

Over the course of the week, the team consulted 47 patients, with 36 surgical procedures undertaken including a number of cleft lip and palate repairs, burn scar contracture releases and the treatment of other congenital and acquired conditions.

The visit included a significant training component, with ni-Vanuatu surgical registrar, Dr Samuel Kemuel, travelling from his training at the Fiji School of Medicine in Suva to be present with the Interplast team in Port Vila. Dr Kemuel pre-screened patients in the lead up to the team's arrival and assisted with most procedures performed by the Interplast team. Other hands-on training was provided to the local surgeons, anaesthetists and nurses throughout the week and a lecture was delivered by Mark Duncan-Smith on wounds and acute burns care.

VIETNAM

Country Coordinator: Dr James Masson (previously Mr Allan Meares)

In November 2012, a program review of the effectiveness of Vietnam's current country program was undertaken. A team of two volunteers and one staff member visited four cities where Interplast have previously implemented activities – Ho Chi Minh City, Da Nang, Tam Kỳ and Hanoi – to review what ingredients are required for successful future programming.

Over a five-day period the review team visited the Hospital for Traumatology and Orthopedics and Cho Ray Hospital in Ho Chi Minh City, Da Nang Hospital in Da Nang, Quang Nam General Hospital in Tam Ky and Saint Paul Hospital and National Hospital of Pediatrics in Hanoi. Meetings were held with key plastic surgeons and their staff, as well as with the Australian Consul-General, senior AusAID representative and various non-government organisations.

As a result, Interplast will implement activities in the 2013/14 financial year with a focus on capacity building, specifically around hand surgery and advanced microsurgery mentoring.

ESALA VAKAMACAWAI FIJIAN SURGICAL REGISTRAR

"Fiji is a developing country with 45 per cent of people living in poverty. I realised that in this specialty, I could make a difference to many of these people who cannot pay for overseas treatment. I am currently studying as a second year student in the postgraduate Masters in General Surgery at the Fiji School of Medicine. My interest in plastic surgery began a few years ago after witnessing tears of joy from a mother after seeing her son's outcome of a cleft lip repair.

I thank Interplast for sending teams to Fiji and giving patients a fair chance for treatment. I have worked with the teams in Lautoka, Labasa and Suva where these attachments have exposed me to quality surgical procedures and principles that will allow me to become a skilled and safe surgeon in the future. It also ensures that when the teams return home, I should be able to continue what they have started.

This year, I've been sponsored by Interplast to attend two additional attachments. This has not only broadened my knowledge but has also given me a chance to meet other surgeons from neighbouring countries. We have initiated a network where we can discuss cases and ideas – there's always more than one solution to a single problem! I look forward to working with the Interplast teams towards changing lives in Fiji and the Pacific region in the future."

"When my granddaughter, Vinna, was seriously burnt in a house fire a few years ago, I was very sad and very worried. My family is poor and I wasn't sure how I was going to get her the help she needed. That's when WIG (Women's International Group) stepped in - they came to see Vinna in ICU at Mahosot General Hospital in Vientiane and they helped out by moving her to a rehabilitation centre called COPE (Cooperative Orthotic and Prosthetic Enterprise) when she felt better. They also told me an Interplast team was coming soon.

Vinna had her operations to release her burn scar contractures on her arm and leg. I am so appreciative of the excellent job the Interplast team did. It's totally changed her life! They took very good care of Vinna and always came into the ward to visit her. She's getting better every day and she really has become a new person – she can do everything by herself now. She's very cheerful!

Without Interplast, she would have been a disabled person. She wouldn't have been able to do anything by herself. She wouldn't have been able to walk. She would have been a burden and our lives would have been very difficult. Now, she's a great granddaughter with a new life – she will be a normal person thanks to Interplast."

Interplast has been delivering surgical and training activities in Fiji since 1983. In recognition of our 30th anniversary and our lengthy involvement in the country, we implemented our very first major impact/evaluation study in February 2013. Pulling together the history of all the programs and people involved, it assessed the impact Interplast's programming has had in repairing bodies and rebuilding lives in Fiji.

Stretching over a period of 12 months, the study included three components – a desktop review of all historic documentation relating to Fiji's program, in-Australia interviews and surveying of Interplast volunteers who've participated in Fiji, and an in-country component, consisting of eight days of interviews. After over 60 interviews with participants, including past patients, families, local trainees and other key stakeholders, the study concluded that Interplast has had considerable impact in Fiji over the past 30 years. Highlighting the invaluable role our

teams have played, and continue to play, in the Fijian medical landscape, the study found that Interplast has had a significant impact on the lives of many Fijian patients and families in terms of reducing or reversing disability. It also emphasised the substantial contribution Interplast has made to the development of the Fijian surgical health sector.

With a number of recommendations for continued improvement for Interplast's Fiji programs, many of which are also relevant to other countries in which we work, the study has set the benchmark for a more effective understanding of our longitudinal impacts.

But now, she is in class three and she is a normal little girl. Everything is okay now."

"I've had the privilege of accompanying the Interplast surgical team to Madang in Papua New Guinea on two occasions. Hand trauma is part of daily life in PNG, often resulting from bush knife injuries and burns. But, with only one physiotherapy school in PNG, therapists are faced with enormous challenges.

The students I worked with were extremely keen to learn and were quick to demonstrate good clinical reasoning as we discussed and implemented treatment protocol for each patient. They were excited to see that their newly learned interventions were often generating significant clinical change within a matter of days! The hand therapy textbooks I had left with the department in 2012 were well-thumbed, too. This was so personally satisfying!

The most challenging aspect has been the lack of basic equipment and materials. Scissors are scarce and existing ones are blunt. Elastic bands and safety pins for splint-making are not available so I came prepared on my second visit! We brought a whole new meaning to the word 'improvisation' and we quickly learned to work with whatever was available! Upon reflection of my experiences, I am reminded of Lao Tzu's proverb: 'The journey of a thousand miles, begins with one step.'"






