the MOTIVATION

People born with a disability such as cleft lip and palate face a life time of unnecessary struggle and isolation. Eating is difficult because there is no continence of the mouth which leads to nutritional problems, and a cleft palate makes speech difficult to understand. Children with cleft palates tend not to go to school because they are teased by their peers or because they are hidden from the world. Without an education or prospect of marriage they face a lifetime of struggle and are a continual burden on their families and community. Yet a relatively simple operation can change all of that in just over an hour. Surgical repair of the lip and palate means they can eat and speak like their friends. They go to school, get an education and become independent and contributing members of their families and community. More than 6 million people living in the worlds poorest countries suffer severe burns every year. Left untreated, burns can leave victims unnecessarily disabled forever.

Untreated burn injuries scar and contract, causing almost unimaginable disfigurement and loss of function. Victims may be left unable to use their arms or legs and the effect it has on their appearance and self esteem is devastating. Surgery that releases the contracture and grafts new skin to the injury can give the victim freedom of movement, independence and a renewed sense of worth and confidence.

the DEDICATION



Nearly two thirds of plastic and reconstructive surgeons in Australia and New Zealand have volunteered for Interplast programs.

Over 600 volunteers have been on almost 500 programs, conducting 30,000 consultations and over 18,000 operations.

Every Interplast volunteer is fully qualified in their field of expertise. Every year, surgeons, anaesthetists, nurses and allied therapists from Australia and New Zealand volunteer again and again to help those most in need. The value of these services is estimated at just under \$2m., a figure Interplast and the countries in which they volunteer, simply could not pay.

It is the steadfast and overwhelming generosity of our medical volunteers and the continual influx of new, talented and willing volunteers that fuels the unique spirit of Interplast. In addition to the treatment the medical volunteers provide, and the training delivered to overseas medical personnel keen to learn new and better ways to help their patients, there are also many volunteers who work behind the scenes. Country coordinators and committee members ensure treatment and training is provided appropriately to maximise the growth and development on the local health system. Rotarians and other passionate individuals spread the word of Interplast's life changing work and raise funds on our behalf. Many other committed people provide essential assistance with the logistics and administration of Interplast's activities, both in Australia and in the countries where we work. It is this combination of skills and dedication that makes repairing bodies and rebuilding lives a reality.

the DESTINATIONS




10% of the global health burden can be alleviated by surgery alone, 90% of this burden is in developing countries. *World Health Organisation*

Interplast was established to provide access to free plastic and reconstructive surgical treatment to those in need, in developing countries surrounding Australia and New Zealand. For almost 26 years Interplast volunteers have provided treatment and training in 24 countries in the Asia Pacific region.

Many of these countries have become popular holiday destinations, yet their health sectors, and access to the health services we take for granted, have not grown at the same pace as their tourist industry.

Health systems remain over stressed and under resourced, with most struggling to meet the demands of providing basic health care, while the incidence of congenital deformities, traumas and burns remains disproportionally high compared with the developed world. Without our help to fill the surgical needs, the patients face a lifetime of living with treatable disabilities.





the WINNING COMBINATION

It is never forgotten that without you, Interplast volunteers could not help the patients and health systems in the developing countries in which they work. It is thanks to the generosity of so many people that the disabled and disfigured can receive the surgery they desperately need, and the overseas doctors and nurses can receive the training they so eagerly desire.

Bangladesh

Interplast began providing reconstructive surgery training and service assistance to the Dhaka Medical College Hospital (DMCH) in 2004. Since then it has been identified that many of the hand surgery patients treated at DMCH are discharged from hospital following reconstructive surgery with no access to rehabilitation therapy. This leads to a major underachievement of potential improvements in function for patients, limiting their capability to be self reliant and contribute to their community. Hand therapy is required to maximise the postoperative outcomes of hand surgery patients and to prevent reoccurrence of deformity following surgery.


Since 2007, Interplast volunteers have been working at the Centre for the Rehabilitation of the Paralysed (CRP) to establish access to hand-therapy services in Bangladesh. This year, a clinician from CRP and a lecturer from the Bangladesh Health Professionals Institute (BHPI) were selected to attend a training attachment in Melbourne. Upon their return to Bangladesh, they shared their knowledge with colleagues and students which led to the establishment of the first hand therapy unit. This unit was officially opened at CRP during an Interplast training visit in April 2009. Educational resources and equipment for the unit were funded by the project and referrals have increased steadily from 25 patients in the first month to 57 for the month of July 2009. Two training visits were delivered by volunteer Occupational Therapists providing lectures and practical training sessions as well as clinical supervision and mentoring. A relationship was also initiated with the Faculty of Occupational Therapy at Monash University which promises to further develop and strengthen the local training curriculum.

Sincere thanks must be extended to Interplast's Volunteer Coordinator in Bangladesh, Mr Atom Rahman. His commitment and assistance with local arrangements is invaluable, and his enthusiasm, energy and hospitality are greatly appreciated by Interplast volunteers and staff.



Laos

Local capacity to treat cleft lip and palate patients in Laos has been realised following over 10 years of training from Interplast. In February 2009, the Mahasot Hospital Cleft Team from Vientiane delivered their 2nd outreach program in Xayabouly in the province of Sayabouly. The team were supported by Interplast nurse, Kerrie Westwood who has overseen the development of the local team since their training first began. 24 patients received treatment for cleft lip and palate deformities and the Mahosot team also provided training to the local hospital staff – a true reflection that the capability of the local team to deliver services has been established. Interplast training programs now focus on the management of burns and the second burns training program was delivered at Mahosot Hospital in Vientiane during February 2009. Working alongside the local staff in the Plastic Surgery Unit, the Interplast team operated on 53 patients and training was provided to the local surgeons, anaesthetists and nurses. A surgeon and anaesthetist were also funded to undertake a 10 week training attachment at Princess Margaret Hospital in Perth, further strengthening capacity of the local team to treat burns patients.




Mongolia

Anaesthesia plays an integral role in surgery and is also crucial in intensive care, resuscitation, emergency care and operative obstetrics. In association with Anaesthetists from the Australian Society of Anaesthetists, Interplast has commenced working with the newly established Mongolian Society of Anaesthetists (MSA) to implement safe anaesthetic training in Mongolia.

This year, the program has supported the development of training materials and curriculum, and established an anaesthetic resource centre. A local project coordinator has been employed to supervise the trainees enrolled in the new anaesthetic training program, with the first intake to commence in September 2009.

In June 2009, 100 Mongolian anaesthetists attended a 3 day Airway Management Seminar arranged by the MSA and delivered by six volunteer Australian anaesthetists. Over 100 anaesthetists and trainees attended, including 20 rural anaesthetists. For many of these rural anaesthetists, this was their first opportunity to participate in further education. This course also educated senior Mongolian anaesthetists to become future trainers.



Nepal

At the invitation of the phect-NEPAL Kathmandu Model Hospital, Interplast volunteers initiated training in microsurgery at the hospitals Plastic Surgery Unit. With funding assistance from AusAID, five microsurgery training modules have been delivered from 2007 to 2009. Two modules were delivered this financial year, involving 11 Interplast volunteers who provided training and mentoring to the surgeons, anaesthetists, nurses and therapy staff. During the last module, the Nepalese surgical team took the lead role in each operation and Interplast country coordinator for Nepal, Mr Russell Corlett, observed a notable development in skills.

This program is developing leaders in the advancement of reconstructive surgery in Nepal and access to appropriate, life changing treatment for patients disabled by a range of trauma injuries, burn contractures and tumours.



Pacific Island Countries

The Pacific Islands have a small surgical workforce and there is only one fully qualified plastic surgeon in the region. The need to provide access to reconstructive surgery for patients in the region remains a priority.

This year, the AusAID funded Pacific Islands Project managed by the Royal Australasian College of Surgeons provided funding for Interplast teams to Samoa, Fiji, Kiribati, the Solomon Islands and Tonga. In total 262 operations were performed on patients who would otherwise not have been able to access treatment. A range of conditions were seen including congenital hand deformities, cleft lips and palates, hand injuries and debilitating burn contractures. Training was also provided to local medical and nursing staff, and where possible, local doctors undertaking the Master of Surgery program at the Fiji School of Medicine returned to their home country to participate and work along side the Interplast surgeons.

An additional program to Taveuni in Fiji was also delivered with funding from Rotary. This program provided access to cleft lip and palate surgery for patients from some of Fiji's most remote and disadvantaged Islands who are unable to travel to the main Island for treatment.



Papua New Guinea

The AusAID funded PNG Tertiary Health Services Project (PNG-THS) managed by the Royal Australasian College of Surgeons funded two Interplast programs to Papua New Guinea this financial year. Services were delivered in Rabaul, Buka and Port Moresby, and 45 patients were treated.

The local surgeons who worked with the Interplast team in Port Moresby expressed their appreciation of the teaching and supervision they received from the Interplast volunteers. In addition to the usual difficulties faced by Interplast volunteers working in under resourced environments, the team in Rabaul were further challenged by a hospital drenched in ash, smoke and acid rain from the near by active volcano. In Buka the number of patients seeking treatment was far greater than expected and fortunately, local plastic surgeon Dr John Maihua also joined the team. Dr Maihua was a valuable asset and, in addition, benefited from the opportunity to receive further professional development.



Philippines

Interplast programs to the Philippines provide access to treatment for indigent patients who would otherwise be forced to live a life with treatable disability. 69 life changing operations were performed on 52 patients during the Interplast program delivered at the Benguet General Hospital, Baguio, in November 2008. Patient referrals and local coordination were provided by Interplast's local partners, the Save Our Street Children Inc and the Cabrini Sisters. There is already a waiting list for the next Interplast visit which has been scheduled for November 2009. In January 2009, the Interplast program to Cagayan de Oro in the Philippines was delivered once again in cooperation with the Rotary Club of Cagayan de Oro City, the Philippine Service of Mercy and the German Doctors Hospital. Fifty nine patients were treated and 84 cleft procedures performed in total. A volunteer speech pathologist also accompanied the team and initiated training to staff in the assessment and management of speech problems commonly associated with cleft palate. This important training will continue during the next program scheduled for October 2009.



Sri Lanka

A hand surgery training program was delivered in Sri Lanka in October 2008 by Plastic Surgeon Mr Randall Sach and Orthopaedic Surgeon Mr Greg Hoy, both members of the Australian Hand Surgery Society. In collaboration with the staff at the Plastic Surgery Unit of the Colombo National Hospital, 31 patients were treated including a number of acute hand trauma cases. The team was also accompanied by hand therapist Mrs Kathy Minchin, who worked with the Units occupational therapist to provide specialist training. The Interplast team also delivered a two day hand trauma training workshop attended by approximately 100 delegates including 30 occupational therapists, and a large number of surgical trainees from all disciplines. While in Sri Lanka, production also began on a hand trauma training resource. DVDs are being developed as an educational resource for surgeons in the countries where Interplast works.

With sustained funding support from the Colonial Foundation over the past 8 years, a significant contribution to local sustainability in Sri Lanka is being realised.



Vietnam

Unfortunately the scheduled burns program to Cho Ray Hospital in Ho Chi Minh City in February 2009 coincided with the devastating Victorian Bush Fires. The Victorian based Interplast team were left with no choice but to postpone their program to attend to patients at home. A reduced, but dedicated team of four volunteers departed four days later to honour their commitment to Cho Ray Hospital and the waiting patients. 15 patients were treated and training and lectures were provided to the staff of the plastic and orthopaedic surgery units. Dr Dao, head of the Plastic Surgery and Burns Unit noted his appreciation of "the working spirit of the Interplast team". He reported, "The Interplast team have cured the burns patients effectively and also improved and provided our local doctors with knowledge."

Emergency Management Of Severe Burns Training

With the presentation of patients with severe burn injuries becoming an increasing concern for Interplast teams, Interplast has collaborated with the Australian New Zealand Burns Association (ANZBA) to deliver training in the Emergency Management of Severe Burns (EMSB) in an effort to combat the massive burden of disability caused by poor early treatment of burn injuries. The world renowned EMSB course is delivered by qualified ANZBA Instructors and teaches how to appropriately manage the crucial first 24 hours following burn injury.

In Bangladesh, Interplast is working with the Centre for Injury prevention and Research Bangladesh (CIPBB) to facilitate the training, and this year 96 senior burns practitioners in Bangladesh have received training in the acute treatment of burns. 20 outstanding delegates also qualified as Instructors and a Bangladeshi Faculty has now been established. The aim now is to support the Bangladeshi Faculty to extend the delivery of these courses to the main regional centres.

In March 2009, with funding support from Colonial Foundation and the AusAID Papua New Guinea (PNG) -THS Project, a second round of PNG EMSB courses was delivered in Madang, providing training to 36 participants from Lae, Madang, Vanimo, and Wewak. The ANZBA Faculty was joined by 2 Instructors and 1 Coordinator from PNG, and an instructor from the Solomon Islands, all of whom had been trained during the first EMSB courses held in Port Moresby in 2008. Key PNG Coordinator, Ms Stephanie Damong, also benefited from a training attachment to Australia, where she attended the annual ANZBA scientific conference and spent time at a number of burns units around Australia.

EMSB courses were also conducted at the Fiji School of Medicine in Lautoka during June 2009. Delegates from around the pacific region and Fiji travelled to Lautoka to participate. 68 consultants, surgical and medical registrars, and nurses received training. Two instructors from PNG also joined the Australian Faculty to deliver the course.

Following the course, Dr Arun Murari noted that "the EMSB course has been well received by our Department doctors and the burns unit nurses. There is an increased feeling of confidence in handling burns cases."

Thanks are extended to the ANZBA secretariat for administration support to mobilise the volunteer ANZBA faculty.






